Peak Diaries".

### **5. HOW TO**

#### **PARTICIPATE**

In order to participate to this initiative, users must:

- 1. Download the app "My Livigno" (available on Apple Store and Google Play Store),
- 2. Register on the app (by entering their fist name, last name, email and password) to create a MyLivigno account
- 3. Click on the confirmation link you received via email (at the address specified during registration) to activate your MyLivigno account
- 4. Log in on the app (with your registration data)
- 5. Go to the special initiative section, "3000. Peak Diaries" and click on "Participate"

<sup>\*</sup> The personal data (first and last name) entered during the registration phase must match those on the ID document (a copy of which will be requested to the user when they collect the complimentary gift).

Anyone who, after following the steps below to register, will reach at least two locations established by the Promoter (ref. Point 6 of these Rules) and will take a picture of the QR Code at the location with the MyLivigno app, will receive a gift to be collected at the tourist offices during office hours

You can register and participate to this initiative every day of the week, for the entire duration of the initiative (from Monday 26 July 2021 to Saturday 30 September 2023).

Every user can register once. The system will perform all checks due to prevent multiple registrations. All further registration attempts (after the first one) will be blocked and invalidated.

### 7. <u>GIFTS</u>

Everyone who reaches at least 2 peaks (among those listed in Point 6) and will scan the QR Code on each peak reached, can collect the complimentary gift in one of the two Livigno tourist offices, at the following addresses:

The gifts (assigned after reaching 2 peaks) include a custom snap hook with the name of each peak conquered. Also, you'll receive a larger snap hook to hold the smaller ones. The large snap hooks will also be given after conquering the second peak.

To collect the gift, you need to visit the tourist office personally, and show your smartphone in the section dedicated to the "3000. Peak Diaries" initiatives in the MY LIVIGNO app to the office clerk.

If, for instance, a user has conquered the Al Filòn – Pizzo Filone and Corn da li Cabra – Corna di Capra, peaks, they will receive three snap hooks at the tourist office, one marked Al Filòn – Pizzo Filone, one marked Corn da li Cabra – Corna di Capra and the large snap hook.

It is specified that nothing will be given to participants who conquer just one peak.
